Georgson gave a summary of his written report. He reported that things are beginning to finish up for Farm Technology Days. With a large show there are a lot of loose ends. The County is waiting for final numbers to come in from the state; preliminary numbers should be out to the Executive Committee which is meeting on September 24. Georgson is confident that it will be a good show. Jefferson County is now working closely with Eau Claire County to transfer the knowledge gained to the next host County.

Georgson added that the Master Gardener group continues to offer horticulture helpline twice a week in the Extension Office and has been handling most of the horticulture questions. Crops are about two weeks behind schedule. Questions have been coming in on land rental amounts.

Loyd provided a summary of her written report. 4-H Enrollment for the New Year opened last week and runs through November 1. Jefferson County has one club that is disbanding and one new club forming. Loyd has been busy working with committees and their new committee members getting them up to speed.

Krolow stated that she is wrapping up budgets. The FoodWlse positions is posted and open through September 22<sup>nd</sup>. Krolow is hopeful that the new individual will be on-board November 1. She has continued her outreach to build relationships, i.e. United Way.

Steve Chmielewski provided a written report which was handed out to committee members for their review.

## **Agriculture Programming**

Farm Technology Days (FTD) Programming:

The amount of details is diminishing with the primary focus on the financial aspects of the show and closing the books.

The treasurer for the Jefferson County 2019 FTD show used her remarkable talents to organize, record and maintain the financial records to the highest degree. Her thoroughness in anticipation, preparation and process has contributed to the success of our effort. I don't think there was anything that she did not expect or have a strategy for.

The officers of the Executive Committee and I met to review the numbers and financial information available from the show. There were some pleasant "surprises" that refutes some of the speculation that swirled around regarding the information or more correctly the misinformation that was part of the rumor culture following our show.

The Wisconsin Farm Technology Days State General Manager has determined and announced the attendance as 24,700 over the three days. This is fairly consistent with the announced attendance at three of the last four shows with the 2016 Walworth County at 25,000, 2017 Kewanee County at 27,000. 2018 Wood County is the anomaly with 40,000.

While there was a general sense of light crowds or low attendance the numbers fall in line with what may be a new trend. The reality of maintaining the show in its current format or continuing the historical template is raising questions in many areas.

The vast majority of exhibitors were generally pleased with our show. With the few exceptions that I am aware of, exhibitors were pleased. The quality of show attendees being serious and interested in the products that they were presenting led to many quality over quantity contacts.

#### Horticulture Programming:

Plant identification and plant health have been leading topics here.

#### **Crops Programming:**

There is continuing concern for our late maturing crops. Corn silage harvesting sporadically began near the end of the September. Corn silage harvest for many people is usually wrapping up by now. The rain has also been a hindrance. The supply of dry hay and the quality are generally projected to be low again this winter feeding season.

#### Dairy and livestock programming:

The Jefferson County Corporate Counsel requested that several other departments and I review a proposed incinerator ordinance on behalf of the Solid Waste Committee. A review centered on perceived or potential safety and environmental hazards, cost and application of the proposed ordinance and employee or company operation of incinerators. A review of DNR and EPA guidance was conducted. It was determined that this time an ordinance is not needed.

#### **Department Activities:**

Among other things my midyear review was conducted with Area Extension Director Chrissy Wen.
