- Call to Order
 - -Chairman Schultz called meeting to order at 8:30 a.m.
- 2. Roll Call (Establish a Quorum)
 - -Solid Waste Committee members present were Dick Schultz, Greg David, Jeff Johns and Peter Hartz. Solid Waste Committee member Roger Lindl was not present. Jefferson County staff present were Blair Ward, LaVern Georgson, Patricia Cicero, Matt Zangl and Brett Scherer. Members of the public present were Victor Karalinunas (Town of Ixonia) and Allan G. Kountz (Veolia)
- 3. Certification of Compliance with the Open Meetings Law
 - -Ward certified compliance with Open Meeting Law
- 4. Introductions
 - -No new introductions
- 5. Approval of the Agenda
 - Schultz approved agenda. No objections.
- 6. Public Comment (Not to exceed 15 minutes Members of the public who wish to address the Committee on specific agenda items must register their request at this time)
 - -Public who signed in were; Janet Foust, Ronni Monroe and Victor Karalinunas (representing self).
 - -Karalinunas wanted the incinerator ordinance to move forward. Karalinunas and colleagues will give any more information needed to Solid Waste Committee. Also, incinerator training manual was handed out by Martin and Karalinunas. Supports the incinerator ordinance.
 - -Foust stated Chapter 13 and importance of educating the public. Stated committee members should be doing their research and come prepared to the meeting for these decisions.
 - -Martin stated this type of incinerator is not regulated by DNR or EPA. Stated this information was provided to all committee members except Roger Lindl who was not present at the last meeting.
 - -Monroe had question on how many chicken mortalities are going to the Deer Track Landfill
- 7. Communication
 - -No Communication
- 8. Approval of Minutes for August 6th, September 20th, September 21st and October 8th.

- -Scherer broke down what each date was for.
- -Motion made by David, seconded by Schultz to approve minutes. Motion carried 5-0
- 9. Discussion and Possible Action on Incinerator Ordinance
 - -Schultz asked Corporation Council and Jefferson County employees to help advise a recommendation.
 - -Ward explained setting up the meeting, who was involved and what took place to come to a recommendation.
 - Ward said it was an unanimous decision that the incinerator ordinance would have to benefit to Jefferson County at this time.
 - Cicero said after contacting the DNR, the incinerator classes are for garbage and not for carcass disposal. Two large farm operations are currently not using any incinerators. The incinerators have not been operated for months because they are inefficient compared to landfilling carcasses.
 - -LaVern spoke about cost, manufacturing training for use and air curtain process take place which makes zero emissions.
 - -Martin- Asked about Daybreak's future plans.
 - -David thanked everyone for hard work, but didn't see too much good coming from the proposed ordinance. David wanted to hear more about the cost and enforcement aspect if the proposed ordinance was to go forward.
 - -Ward said costs of operation would increase if the proposed ordinance was to be enforced.
 - -Zangl stated the Zoning and Planning Department is operating at full capacity currently. Don't have staff time to enforce the proposed ordinance; current programs are already stretched thin.
 - Johns stated that he does not think oversight from the county is needed due to insurance companies already overseeing and manufacturing restrictions.
 - -Motion made by Hartz, seconded by David for no recommendation of the incinerator ordinance to the County Board. **Motion carried 5-0**
- 10. Discussion and Possible Action on Deer Track Park Landfill
 - a.) Landfill Updates Dean Kelley
 - -Dean Kelley not present.
- 11. Discussion and Possible Action on Updates from Ixonia and Watertown Recycling
 - a.) Watertown Update Randy Frank
 - -Randy Franks not present.
 - b.) Ixonia Update Vic Karaliunas
 - -Karalinuas announced retirement on December 31st. Will have replacement taking over-
- 12. Discussion and Possible Action on Appliance Recycling

- -Scherer still looking for a possible site. Spoke on meeting with Refrigerant Depot and Goodwill and how a permanent site could be possible. Spoke on possible partnership with Walworth County.
- 13. Discussion and Possible Action on September 20th, September 21st and October 4th Cleans Sweeps
 - -Scherer spoke about the Clean Sweeps and said numbers of participants were normal
 - -Kountz said things went well. Except Watertown has not been properly packaging their fluorescent bulbs.
 - -Johns spoke about the electronic/appliance recycling, the popularity and traffic. Finding a permanent site should be ideal.
- 14. Discussion and Summary on Drug Collection
 - a.) Drug Take Back Event October 26th, 2019
 - -Scherer explained that the event is a collection of drugs and all Jefferson County law enforcement agencies weigh and turn the drugs over to the DOJ.
 - -Zangl explained the Drug Grant helps pay for the cost of the drug drop-off boxes.
 - b.) Jefferson County Drug Free Coalition Poster
 - -Scherer had an update on the sharp issues in the drug boxes. Explained that new poster are being made to help or minimize sharps in the drug boxes.
- 15. Discussion and Possible Action on Elementary Education Opportunities
 - -Scherer explained the surplus in compost bins. He suggested donating them to schools for green and recycling programs
 - -Johns suggests reaching out to middle schools and high schools.
- 16. Discussion and Possible Action on 2020 Budget and 2020 Grants
 - -Scherer said he submitted the 2020 grant applications and will soon gather all the information for the 2019 final review.
- 17. Upcoming Meeting Dates and Possible Agenda Items.
 - -Schedule next Solid Waste Committee meeting for early December

- 3. Certification of Compliance With the Open Meetings Law
 - -Scherer certified compliance with the Open Meetings Law.
- 4. Introductions
 - -No new members
- 5. Approval of the Agenda
- 6. Public Comment (Not to exceed 15 minutes Members of the public who wish to address the Committee on specific agenda items must register their request at this time)
 - -Public who signed in were; Anita Martin and Frankie Fuller.
 - -Martin had questions for Dean Kelley. Dean Kelley was not present to answer questions.
 - -Martin had comments on the minute layout to help clarify who spoke. Scherer said he would change the layout to clarify this. Martin also had questions on #9 on the minutes from October 8th, 2019. Martin wanted to confirm if Patricia Cicero (Jefferson County Land and Water) contacted the DNR on incinerator training. Martin also wanted to confirm incinerators being used in Jefferson County. Scherer said he would back through the notes and recordings to confirm the exact number of active incinerators.
 - -Fuller had questions on the possibility of Deer Track Landfill and converting to methane such as Dane County's landfill. Zangl said Fuller would have to contact Dean Kelley or someone from Waste Management. Zangl stated they have the capabilities, but Dean Kelley would know what the future plans would be.
- Communication
 - -No Communication
- 8. Approval of Minutes October 8, 2019
 - -Schultz had minutes pending until the questions from public comments were confirmed or needed to be changed.
 - -Motion made by Schultz, seconded by David to check minutes. Motion carried 3-0.
- 9. Discussion and Possible Action-Deer Track Park Landfill
 - a. Landfill Updates- Dean Kelley
 - -Dean Kelley was not present.
- 10. Discussion and Possible Action-Updates from Ixonia and Watertown Recycling
 - a. Randy Frank Update

-Randy Frank was not present. Scherer updated the committee on Watertown's situation with electronic and appliance recycling. Watertown is currently checking on vendors and other options available. Watertown and Ixonia had signed a MOU for mattress recycling.

b. Vic Karaliunas Update

-Vic Karaliunas was not present. Scherer said Vic Karaliunas is retiring and someone new will be taking his spot in the near future. The new Ixonia representative will be at the next meeting hopefully according to Karaliunas.

11. Discussion and Possible Action-Electronic/Appliance Recycling

- a. Mariana Rosado- Refrigerant Depot
 - -Scherer gave introduction for Mariana Rosado from Refrigerant Depot. He explained we currently use Refrigerant Depot's services for our appliance recycling event.
 - -Rosado gave a presentation on their new electronic services and what they can offer Jefferson County. She also explained what other counties are doing, costs and possible program plans.
 - -Zangl explained we previously were working with Legacy Recycling and have an opportunity to switch vendors. Zangl explained to the committee that due to time restraints and getting out new information, Zangl made the decision to switch vendors. He explained he chose Refrigerant Depot because of the more services they provide and with them already doing our appliance recycling.

12. Discussion and Possible Action- 2020 Clean Sweeps, Tire Events and Electronic/Appliance Events

- a. 2020 Schedule
 - -Scherer went over the new clean sweep, electronic, tire and medication schedules for 2020.
- b. Disposal Costs
 - -Zangl said the price of TVs is increasing \$25 to \$35. He suggested the Solid Waste Committee could subsidize the difference of cost from last year. Zangl said fund there are funds that could be used to do this. Zangl said funds would be able to subsidize for short period of time.
 - -Scherer said if they miss the Summer event, they would still have Spring and Fall. Scherer said it comes down to if the committee choosing if they want to go with the \$35 price change or subsidize.
 - -Schultz said we can't keep subsidizing forever and will have to change strictly to \$35 anyways.
 - -David agreed with Schultz that it will have to be raised anyway in the near future.
 - -Zangl mentioned that we could raise the Clean Sweep prices if needed.
 - -Motion made by David, seconded by Schultz to not subsidize the \$35 TV disposal increase. Motion carried 3-0.
- 13. Discussion and Summary- 2019 Drug Collection
 - -Scherer talked about the medication pounds collected at each site and the successes of 2019. He explained we were 300 pounds less than last year, but a few police departments and Sheriff's departments could not drop off medications this year.
- 14. Discussion and Possible Action- 2019 Budget and 2020 Donations
 - -Scherer explained 2020 donation forms were sent out with all the new information. He said as of now we have had \$1000 in donations coming in.
- 15. Upcoming Meeting Dates and Possible Agenda Items
 - -Next meeting scheduled for February 4th, 2020 at 8:30am.
 - -3-0 meeting adjourned.
