Morris and Brantmeier discussed the possibility of a Family Court program. Hall would like to discuss a Veteran Program. They discussed other programs that are already in place that are being utilized. Cauley discussed programs and education offered through Human Services. A presentation on "Every Child Thrives" through the Watertown Health Foundation may be scheduled for a future meeting. The Health Department has some prevention programs as well. Rogge talked about programs that are coming from the Department of Justice. No action taken.

Holler proposed amending the Drug Treatment Court Manual to allow for DOC Supervised cases facing revocation to be allowed into the program as an Alternative to Revocation. The language the CJCC agreed to allow for 5 such cases at a time.




BEEN INCARCERATED WITHIN LAST 3 YEARS




REASON FOR INCARCERATION




DRUGS OR ALCOHOL RELATED






BEEN INCARCERATED WITHIN LAST 3 YEARS





Memorandum of Understanding (MOU)

The Jefferson County Literacy Council, a 501 (c) (3) non-profit literacy organization (hereinafter "JCLC"), and the Community Justice Collaborating Council (hereinafter "CJCC"), share mutual interests in designing and executing programs and services to enhance public safety through community collaboration.

The Community Justice Collaborating Council (CJCC) provides oversite for the correctional education program delivered by the Jefferson County Literacy Council (JCLC) as part of other County efforts to reduce rates of incarceration and recidivism. The Reducing Recidivism Coalition acts as a working subcommittee of the CJCC and is currently chaired by the Executive Director of JCLC.

The correctional education program is partially funded through Title II Adult Education and Family Literacy Act (AEFLA) of the Workforce Innovation and Opportunity Act (WIOA). This Memorandum of Understanding serves to support the critical role of the JCLC correctional education program in providing services to incarcerated adults at the Jefferson County Jail.

WHEREAS, the Jefferson County Literacy Council (JCLC) serves as a standing committee member of the Criminal Justice Collaborating Council (CJCC) and the Reducing Recidivism Coalition (RRC),

NOW, THEREFORE, IT IS AGREED:

- 2. <u>Term</u>. This Memorandum of Understanding shall be effective as of July 1, 2021 and shall be active through June 30, 2025. The parties shall re-examine the extent of this memorandum and the roles of project partners at the end of this period.
- 3. **Funding.** JCLC will serve as the fiscal agent for funds received through the Adult Education and Family Literacy Act (AEFLA). All expenditures will be in accordance with the terms of the activities defined in the grant application. If funding for the activities described in the grant is not secured, this Memorandum of Understanding shall be considered void.
- 4. **Reporting.** The JCLC Executive Director will provide progress updates to the CJCC at regularly scheduled monthly meetings.
