**16. Discussion and possible action on policy revisions. Update on Treatment Court Restructuring Committee (Holler)**

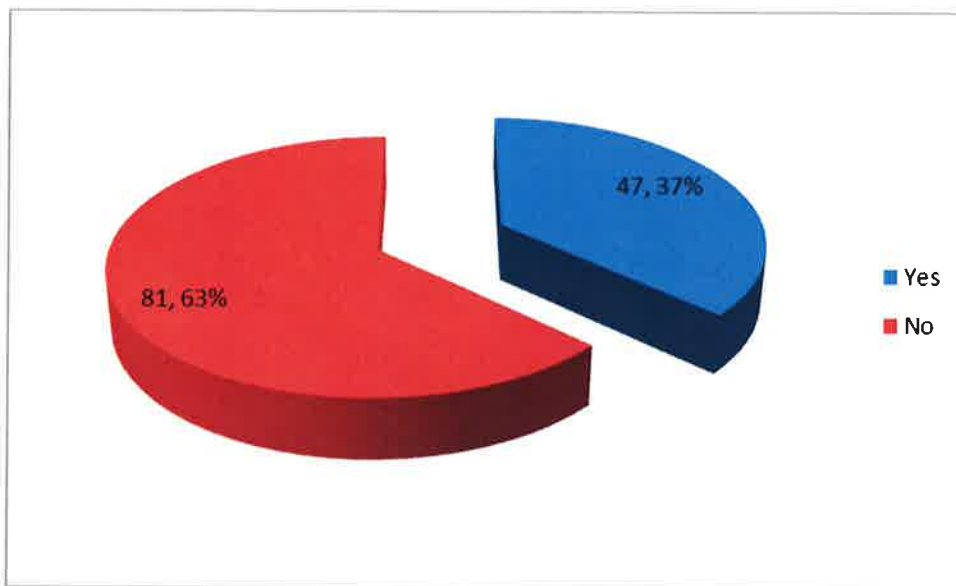
Holler said that he will write up a report explaining the changes. No action taken.

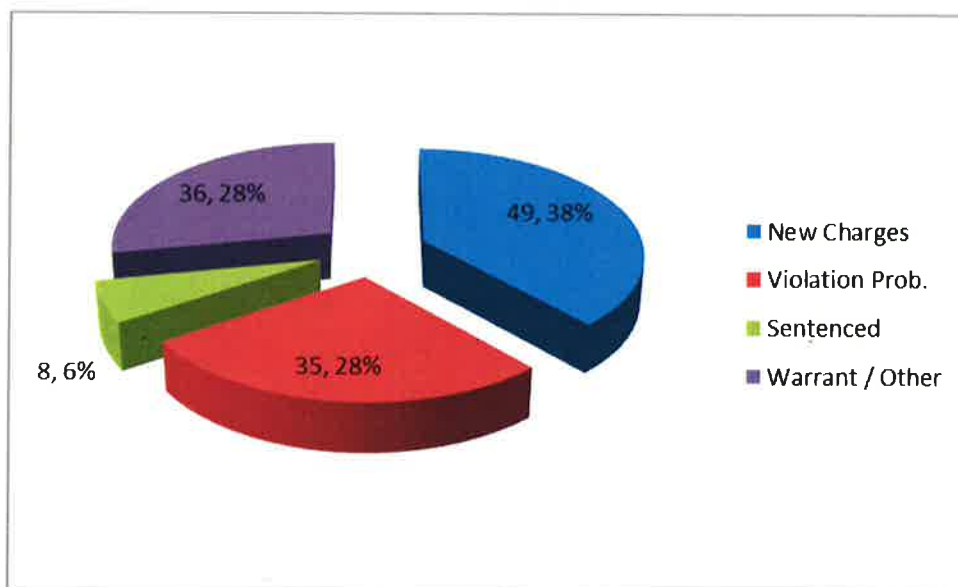

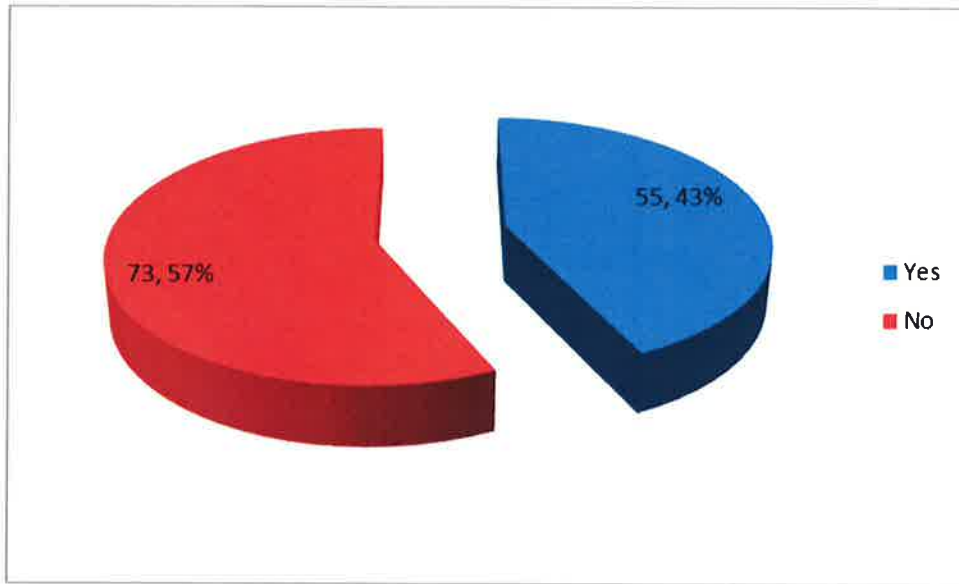

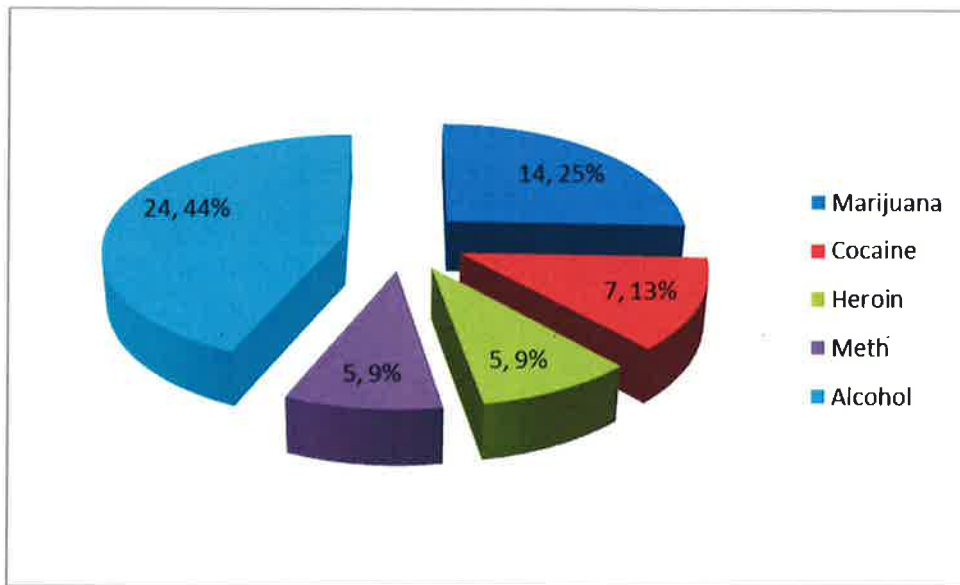
**BEEN INCARCERATED WITHIN LAST 3 YEARS**



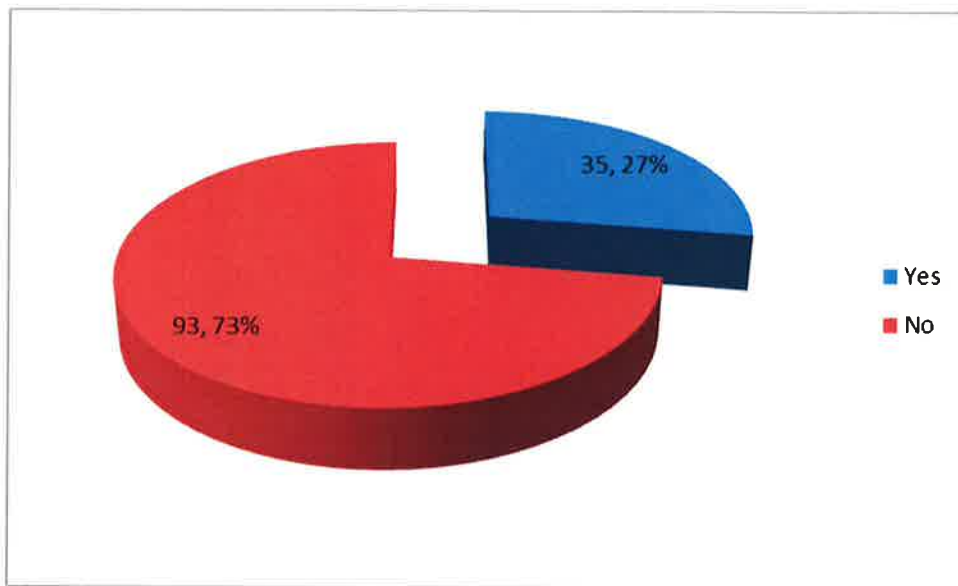
**REASON FOR INCARCERATION**



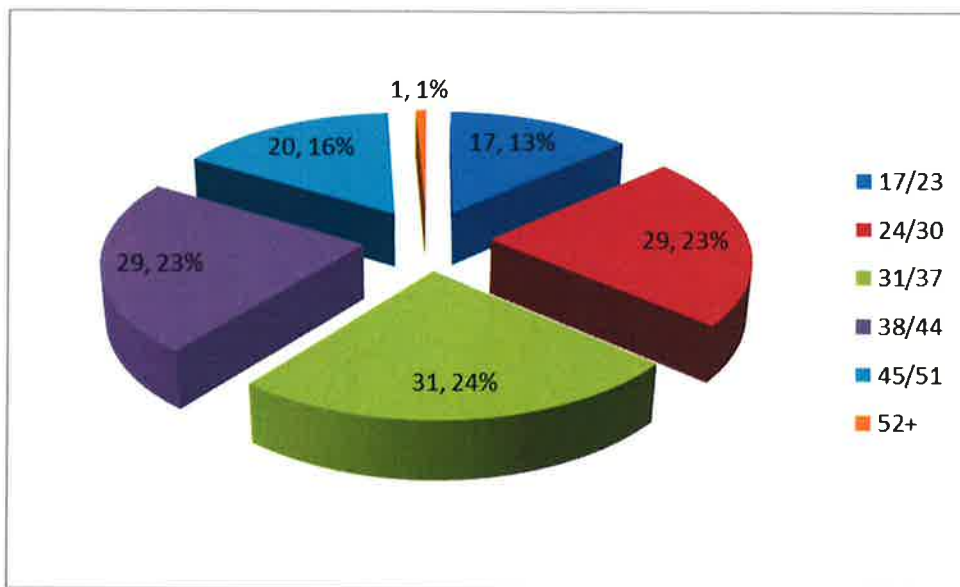
**DRUGS OR ALCOHOL RELATED**



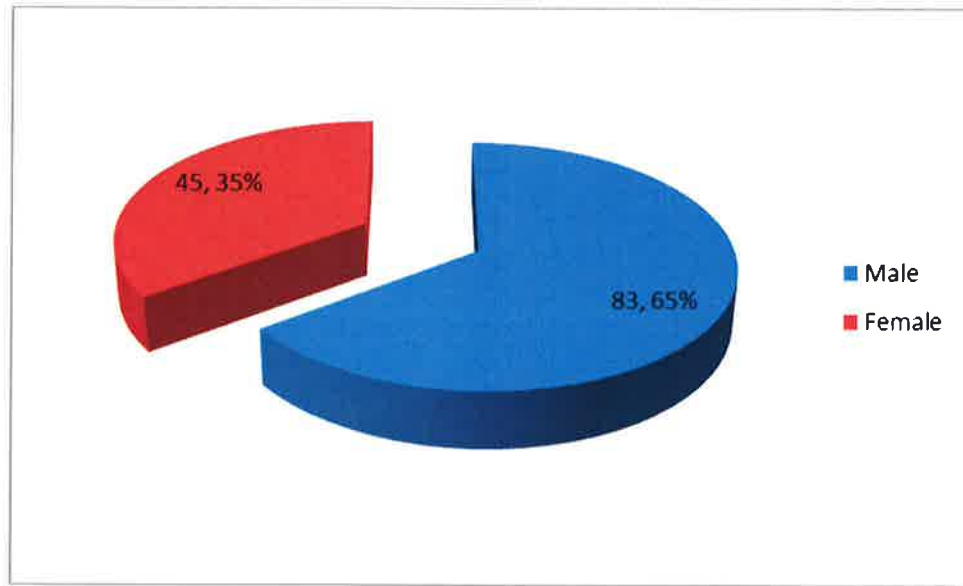
**TYPE OF SUBSTANCE USED**



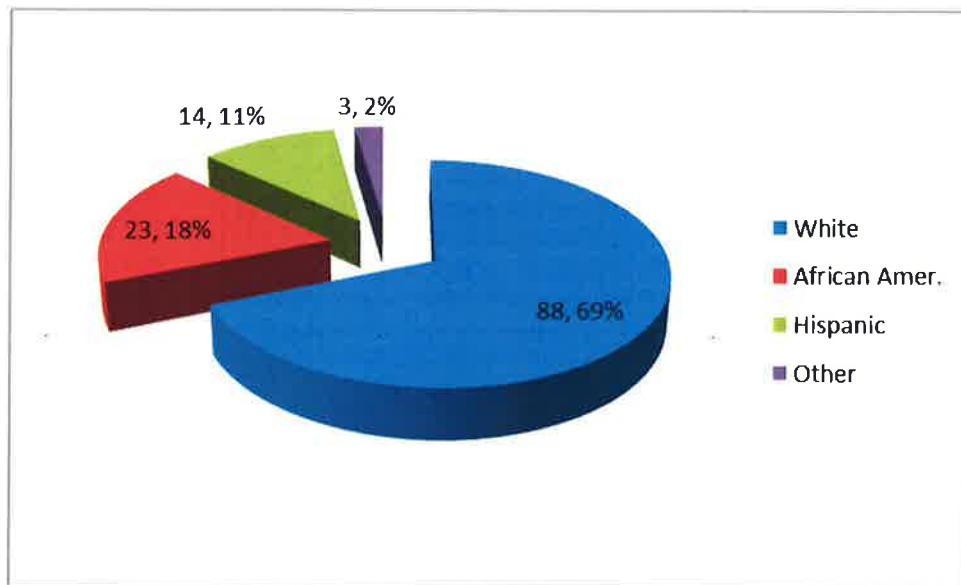
**UNDER INFLUENCE AT BOOKING**



**AGE PROFILE**

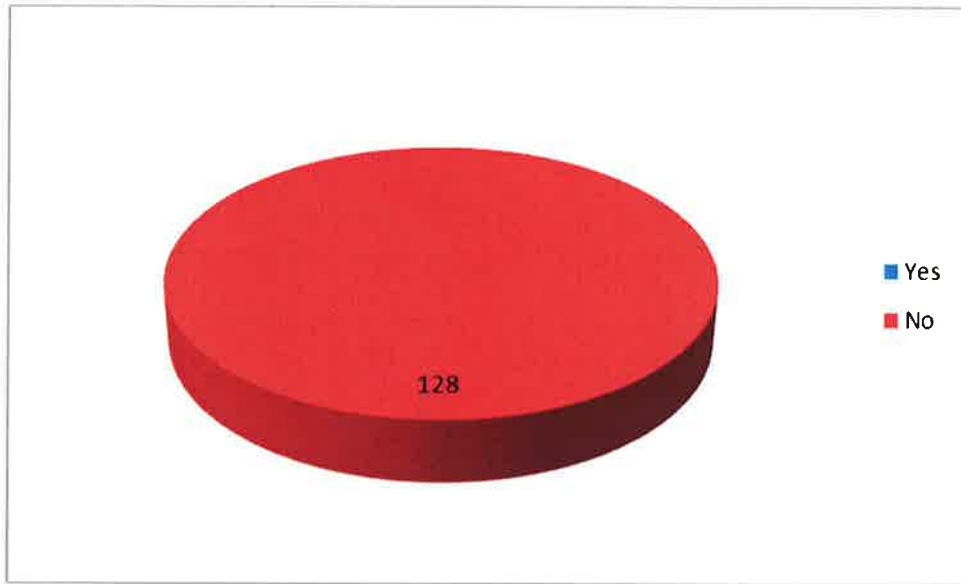


**GENDER PROFILE**

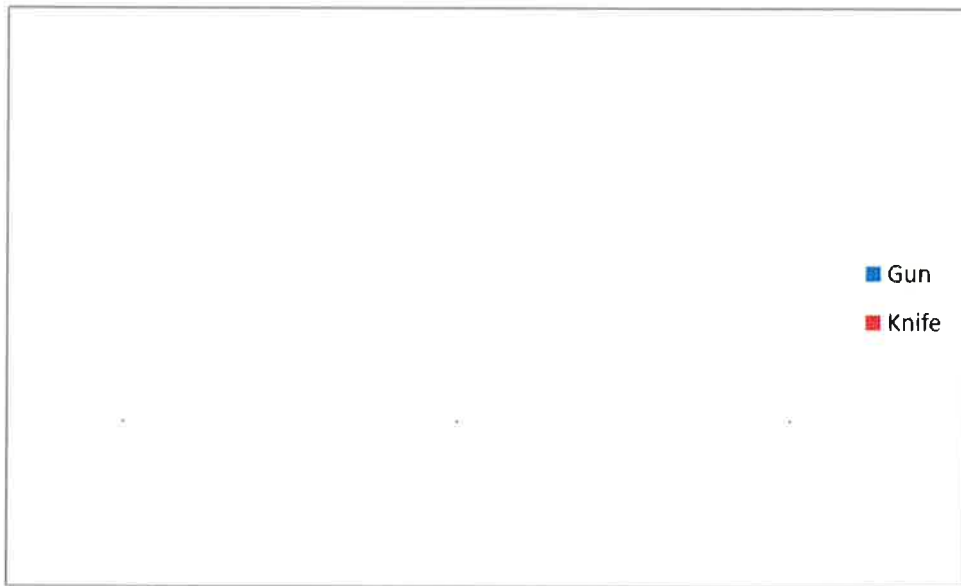


**ETHNIC PROFILE**

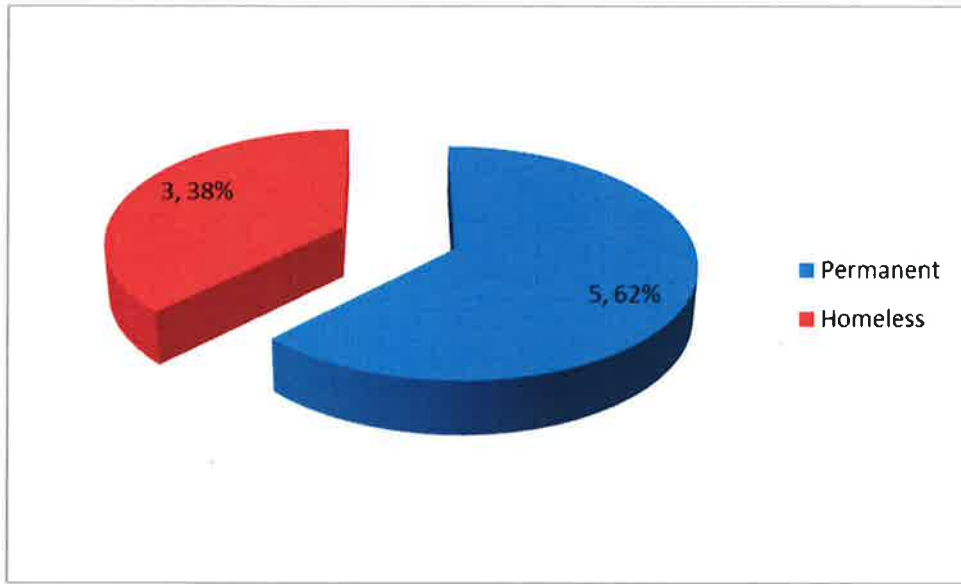




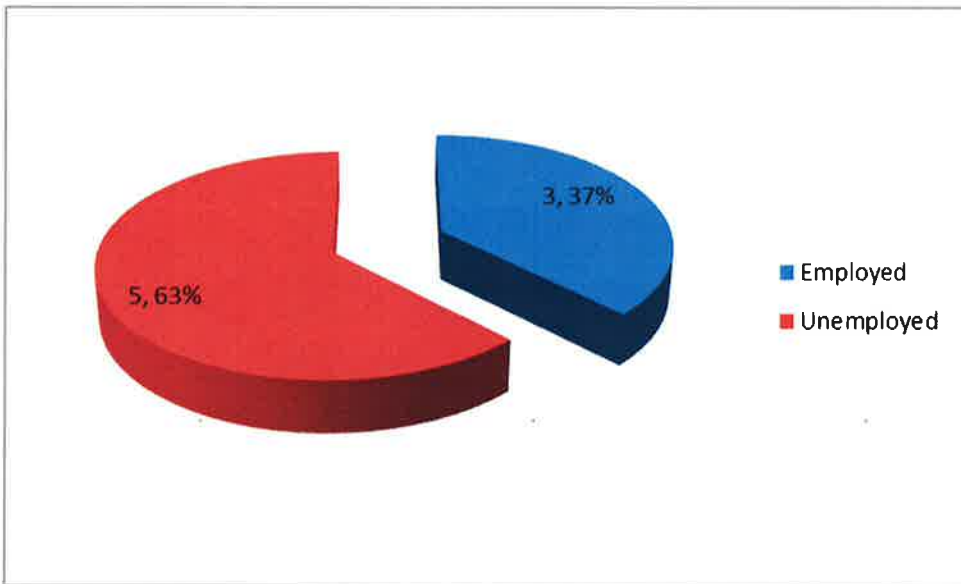
**WEAPONS USED**



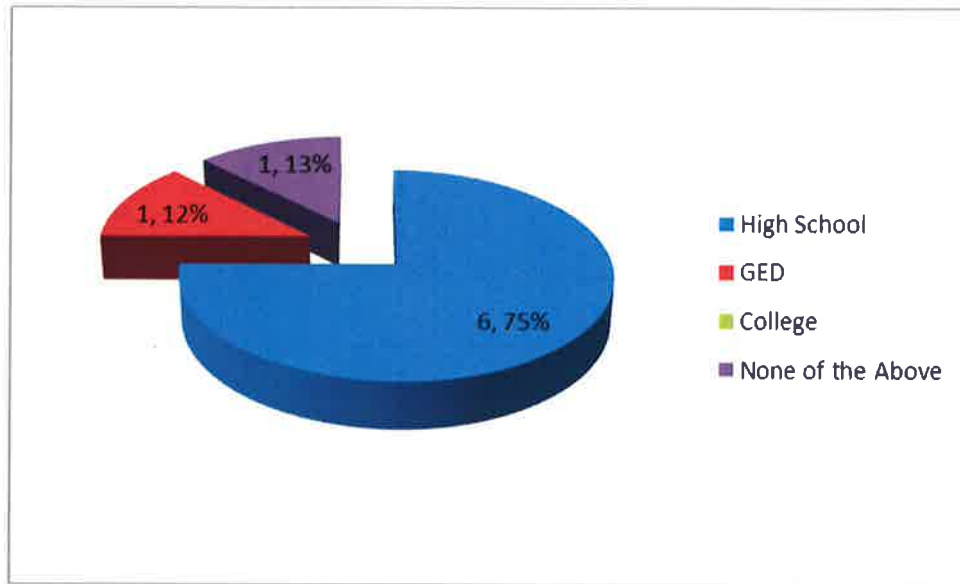
**TYPE OF WEAPON**
