1. Call to Order

Meeting was called to order by Rinard at 9:00 a.m.

2. Roll Call

Mary Rupnow, Dyan Pasano and Tiffany Carey expressed their concerns with the JDA.

Draft minutes were provided for review.

Motion by Nass/Braughler to approve the joint committee meeting minutes from February 19, 2021 as printed. Motion passed 5-0.

7. Approval of February 24, 2021 Executive Committee meeting minutes

Draft minutes were provided for review.

Motion by Nelan/Nass to approve the committee meeting minutes from February 24, 2021 as printed. Motion passed 5-0.

8. Approval of March 9, 2021 County Board meeting minutes

Draft minutes were provided for review.

Motion by Braughler/Nass to approve the County Board minutes from March 9, 2021 as printed. Motion passed 5-0.

9. Communications

- Updated JDA was distributed for review.
- There were Emails to the committee regarding the Joint Development Agreement with We Energies.

10. Discussion and possible action on Joint Development Agreement with We Energies

Ward discussed the changes that were made to the Joint Development Agreement. Chief Schilling responded to questions related to the fire department and the independent study. Nass discussed his concerns with the authority of the Ixonia Fire Department in the JDA. The committee talked through this concern.

Motion by Braughler/Wineke to approve the revised Joint Development Agreement with We Energies and forward to the County Board for their consideration. Motion passed 4-0. (Rinard no)

There was discussion on committee approval prior to sending the JDA to the county board for their consideration. There is concern on adding this to the April County Board meeting. Wehmeier suggested that Ward give the County Board an introduction and overview to the County Board.

11. Convene in closed session pursuant to section 19.85 (1)(e) Wis. Stats. For deliberating or negotiating the purchase of public properties, the investing of public funds, or conducting other specified public business, whenever competitive or bargaining reasons require a closed session, for the purpose of discussion and possible action on entering into a Joint Development Agreement with the Town of Ixonia and We Energies for the development of a Liquefied Natural Gas facility in the Town of Ixonia.

Wehmeier would like to see a resolution that puts this policy guidance and oversight in place moving forward. No action taken.

Please Note: This is not being proposed now, but was under consideration by the committee in 2020 and is being sent out for background purposes.

Remote Attendance

- a. The County hereby adopts the following rules for electronic attendance of Standing Committees as defined in the County Board Rules under section 3.05 and for certain Boards, Commissions, Committees and other Bodies as defined in 3.06 as follows: (c) Board of Health, (d) Community Justice Collaborating Council, (f) Historic Preservation Council, (h) Human Services Board and (q) Veterans Service Commission.
- b. Remote attendance for County Board meetings is strictly prohibited.

<u>Section 1</u>. Rules statement. It is the decision of the Jefferson County Board that any Member appointed to a Committee or Sub-Board may attend any open meeting via electronic means, such as by telephone, video or internet connection; provided that such attendance is in compliance with these rules and any applicable laws.

- a. Attendance for closed session items is prohibited.
- b. Final Action/Quasi-Judicial If a Standing Committee, as defined in 3.05 or Board as defined in 3.06 has been delegated final action authorization by the County Board or through statutory requirement, that member of said Committee or Board must abstained from said vote on said action item. A final action/Quasi-Judicial item is defined to be an agenda item that does not need to move forward to the County Board for final approval or authorization.
- A Member is defined to be an appointee (County Board Supervisor or member of the public) to said Standing Committee under 3.05 of the County Board Rules by the County Board Chair and an appointee (County Board Supervisor or member of the public) to said Board under 3.06 appointed as determined by County Board Rules and/or State Law.

<u>Section 2</u>. Prerequisites. A Member may attend a meeting electronically if the member meets the following conditions:

- a. The Member should notify the County Clerk, Committee/Board Chair and County Administration at least twenty-four hours before the meeting, unless impractical, so that necessary communications equipment can be arranged. Inability to make the necessary technical arrangements will result in denial of a request for remote attendance.
- b. The member must assert one of the following five reasons why they are unable to physically attend the meeting:
 - 1.The member cannot attend because of personal illness or disability
 - 2. The member cannot attend because of personal employment purposes
 - 3. The member cannot attend due to business of the County
 - 4. The member cannot attend because of a family or other emergency.
 - 5. Preplanned absence.

Section 3. Authorization to participate.

After establishing that there is a quorum physically present at a meeting where a Member desires to attend electronically, the Committee/Board Chair shall state that:

- a. A notice was received by a member in accordance with these rules.
- b. The member will be deemed authorized to attend the meeting electronically unless a motion objecting to the member's electronic attendance is made, seconded, and approved by two-thirds of the members physically present at the meeting. If no such motion is made and seconded or if any such motion fails to achieve the required vote by the members physically present at the meeting, then the request by the member to attend the meeting electronically shall be deemed approved by the Committee/Board and the Committee Chair/Board shall declare the requesting member present.
- c. After such declaration by the Chair, the question of a member's electronic attendance may not be reconsidered.
- d. The Chair of a Committee/Board may remotely participate as authorized by this rule; however, they will not be authorized to Chair the meeting during their time of remote attendance.

<u>Section 4</u>. Adequate equipment required. The member participating electronically and other members of the Committee/Board must be able to communicate effectively, and members of the audience must be able to hear all communications at the meeting site. Before allowing electronic attendance at any meeting, the County will provide equipment adequate to accomplish this objective at the meeting site where practicable. If unable to do so, the request will not be allowed. The member requesting remote attendance is responsible for appropriate equipment for their attendance from their location.

<u>Section 5</u>. Minutes. Any Member attending electronically shall be considered an off-site attendee and counted as present electronically for that meeting if the Member is allowed to attend. The meeting minutes shall also reflect and state specifically whether each member is physically present or present by electronic means.

<u>Section 6</u>. Rights of remote member. A Member permitted to attend electronically will be able to express their comments during the meeting and participate in the same capacity as those Members physically present, subject to all general meeting guidelines and procedures previously adopted and adhered to. The Member attending electronically shall be heard, considered, and counted as to any vote taken with the exception of Closed Session items and those votes where the Committee/Board is the final action.

Accordingly, the name of any Member attending electronically shall be called during any vote taken, and their vote counted and recorded by the Committee Secretary and placed in the minutes for the corresponding meeting. A Member attending electronically may leave a meeting and return as in the case of any Member, provided the Member attending electronically shall announce their leaving and returning.

<u>Section 7</u>. Compensation. A member will be paid per diem for attendance at the meeting but will not be paid mileage.

<u>Section 8</u> Report. County Administration will provide a report of Members utilizing remote attendance to the full County Board annually before May 1st, starting May 1, 2021.
