1. **Call to Order**
Meeting was called to order by Payne at 9:00 a.m.

Gammon gave a brief summary on technology and infrastructure needs. There will be a presentation to the County Board on this project at the May board meeting. The committee discussed key points that they would like shared with the county board.
