Motion by Foelker/Jones to approve the March 29, 2021 Broadband Working Group meeting minutes as presented. Motion passed 5-0.

8. Update on broadband grant and project

Wehmeier summarized broadband project activity over the last few months. Bertram continues to add bandwidth and connection points. The towers are complete. There may be an option to run fiber underground. Wehmeier talked about the FCC Rural Digital Opportunity Fund (RDOF). This may be another opportunity to expand broadband. We will be looking at servicing portions of Waterloo, Ixonia, Lake Mills, Jefferson, Koshkonong and Palmyra. The Public Service Commission (PSC) is managing the American Rescue Plan Act (ARPA) and broadband grant funds. Wehmeier talked about the broadband grant process. The deadline for submitting the grant is July 27th. There is more information on the broadband grant available on the PSC website. This will be discussed at the Joint Executive and Finance Committee meeting. The group supports using ARPA funds for the broadband project. No action taken.
