1. Call to Order

Draft minutes were provided for review.

Motion by Wallace/Hamre Incha to approve the minutes from March 23, 2022 as amended. Motion passed 11-0.

5. Public Comment

6. Evidence Based Decision Making and Data Gathering Subcommittee update. Update on Driver's License Clinic.

Holler said that the first two Driver's License Clinics were successful. Rumpf said that people are receptive to the program and hopes more people will be made aware of the program so that they can take advantage of it. No action taken.

Agenda Item # 6.

- A. The District Attorney's Office has begun notifying defendants charged with Operating After Revocation and Operating Without a Valid DL of the Online Legal Tune-up Tool from LIFT WISCONSIN. Defendants are encouraged to use the online tool to reinstate their driving license. If defendants accomplish this by initial appearance, charges against those defendants will be dismissed.
- B. The District Attorney's Office is also offering Deferred Prosecution Agreements to those defendants who have more complicated barriers to reinstatement. Defendants will be steered to the Drivers License Restoration Clinics, (now called Pop Up Clinics) to seek help from LIFT WISCONSIN and Legal Action WI. When defendants demonstrate they have reinstated their driving privileges, their charge will be dismissed.
- C. The Driver's License Restoration Clinics have experienced lower than anticipated attendance. Attendance has been as follows: June-5, July-7, August-3, September-Cancelled, October-3, November-1.
LIFT WISCONSIN and Jefferson County are examining more effective ways to promote the Pop-Up Clinics. One possibility may include direct mailings to those in DMV records as living in Jefferson County and having a Suspended or Revoked DL.
- D. LIFT WISCONSIN is adding menu questions to ID Jefferson County residents using the online Legal Tune-Up Tool. They are also looking at adding a question to identify who was accessing the site because they have charges pending.
- E. LIFT WISCONSIN is scheduling dates for the first six month of next year. Sites for Pop-Up Clinics will likely include Ft. Atkinson, Watertown, Lake Mills and Jefferson.

B: The Treatment Court Team revised a Behavior Matrix for the Treatment Court Programs. The new guide better accounts for participants' phases within the program and tailors the Team's responses accordingly. (see handout)

C: The TAD Grant re-application was submitted on 11/02/2022. The application includes requests to fund enhancements including lab drug testing. Funding was also requested for a 50% psychotherapist position to run a women's Intensive Outpatient Program treatment group and conduct Substance Abuse Disorder Assessment on applicants prior to program acceptance. This position would also be more available during Treatment Court sessions. Funding 50% of this position allow for non-participants to enroll in the same treatment group. A 50% peer support position was also included in the funding request. The position would focus on participants with substantially rural/agricultural backgrounds. Finally, funding was requested for staff retention.

D: The Treatment Court Programs will hold a Graduation Celebration on December 14th at 1:00 pm in Branch 4. Hon. Rebecca G. Bradley of the WI Supreme Court will be the keynote speaker.

Agenda Item # 8 & # 9

A certified Peer Support Specialist has been serving as a member of the Treatment Court Team since the beginning of this year on a trial basis. This individual has proven to be a tremendous asset to the Team by providing insight from the perspective of someone with the same lived experience as our current participants.

The Treatment Court Team recommends the Peer Support Specialist be made a permanent member of the Team.

Agenda Item #10

The Treatment Court Team recommends changing the Alcohol Treatment Court Phase structure from a 4 Phase program to a 5 Phase program. Shorter Phase 1 timeframes allows participants who struggle early in the program to experience success sooner than in longer Phase 1 programs. This encourages those participants to remain in the program, despite early struggles. (see handout)

The Treatment Court Team recommends the new Five-Phase program structure be adopted.

JEFFERSON COUNTY ALCOHOL TREATMENT COURT – OWI 3 & 4 PHASE REQUIREMENTS

Phase Descriptions and Goals

Phase 1 – Stabilization: (4 Weeks)

This Phase is designed to evaluate, closely monitor and ‘stabilize’ participants. Participants will need a period of time to become accustomed to the requirements of a treatment Court but must be closely monitored. Participants must enroll in treatment during this phase and must have their initial appointment with their treatment provider. Those already in treatment at the time they begin the program could advance early of all other requirements are met. Community Support is introduced to participants during this phase. Participants must have 20 days sobriety to advance to Phase 2.

Phase 2 - Engage in Treatment-Continue Recovery: (8 Weeks)

This Phase is designed to closely monitor participants’ progress and sobriety while they are beginning treatment. Participants in Phase 2 are required to make Community Support a larger and regular part of their life, and must obtain a sponsor. They are also required to begin looking for work and to perform Community Service if not employed. Community Service is intended for participants to give back to the community, develop positive work habits and to engage participants in non-using activities with non-using people. Participants must have 40 days sobriety to advance to Phase 3.

Phase 3 - Continuation of Treatment-Establish Community Support: (12 Weeks)

This Phase is designed to continue close (but decreasing) monitoring of participants while they work toward completing treatment. Participants must continue looking for work and complete community service if not employed. They are also required to increase involvement in Community Support once treatment is completed as well as maintain regular contact with their sponsor. Emphasis is placed on increasing sources of community support. Participants must have 60 days sobriety to advance to Phase 4.

Phase 4 - Completion of Treatment-Maintenance of Recovery-Solidify Support: (14 Weeks)

This Phase is designed to monitor participants at a decreasing level following completion of treatment, establishment of longer-term sobriety and overall program compliance. Participants are expected to utilize their sources of community support to maintain sobriety more than program monitoring. Planning for long term sobriety is finalized and presented to the Treatment Court. Participants must have 60 days sobriety to advance to Phase 5.

Phase 5 - Maintenance of Recovery and Support-Program Exit: (14 Weeks)

The final Phase is designed to offer minimal monitoring and supervision while ensuring participants are utilizing their sources of community support. Long term sobriety planning is reviewed and revised where appropriate. Participants must participate in a Pre-Graduation Exit Interview (including a program evaluation) prior graduating. Participants must have 90 days sobriety to graduate.

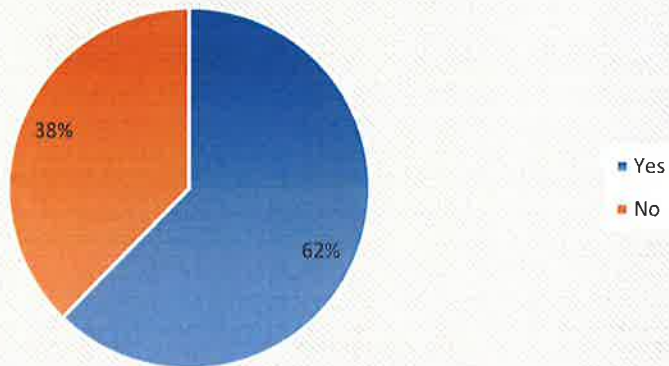

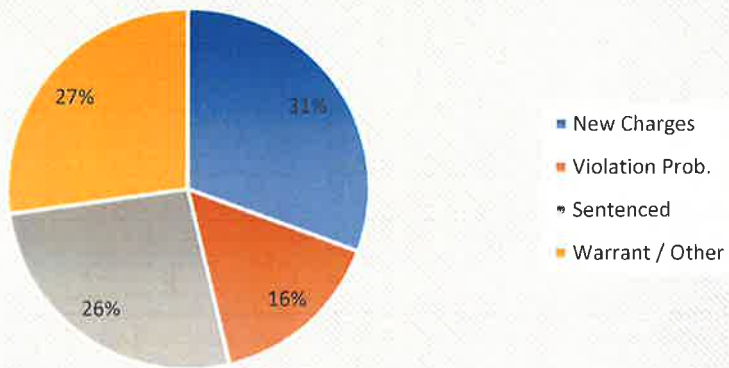

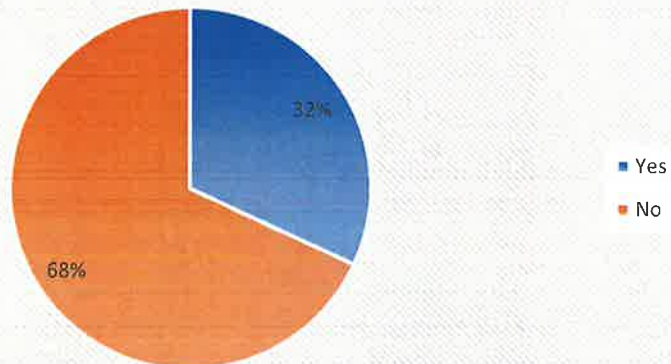
Incarceration Within Last 3 Years



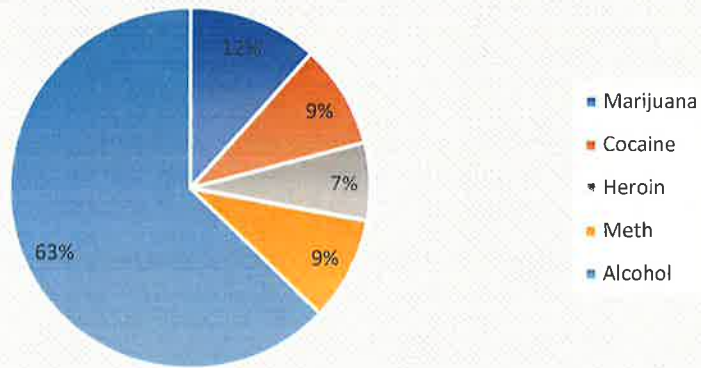
Reason For Reincarceration



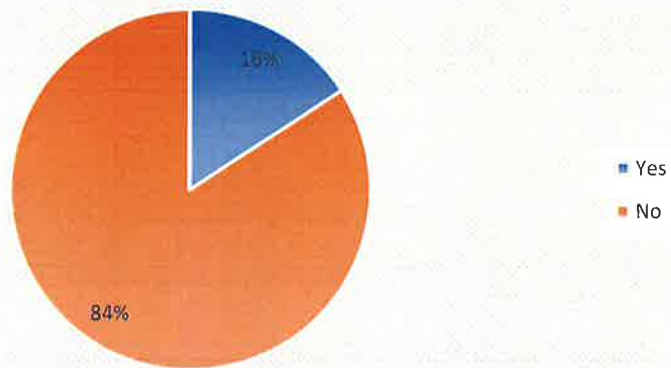

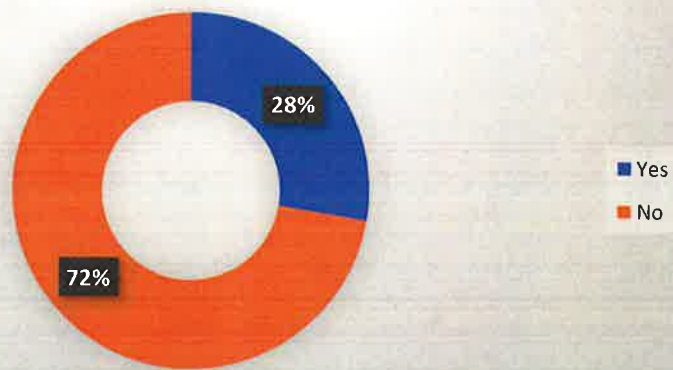
Incarceration Within Last 3 Years



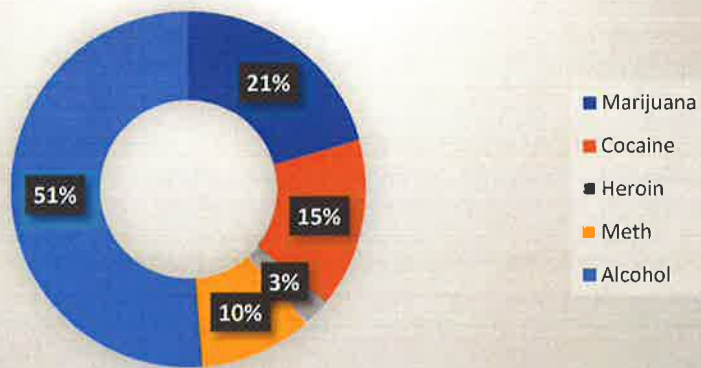
Reason for Reincarceration



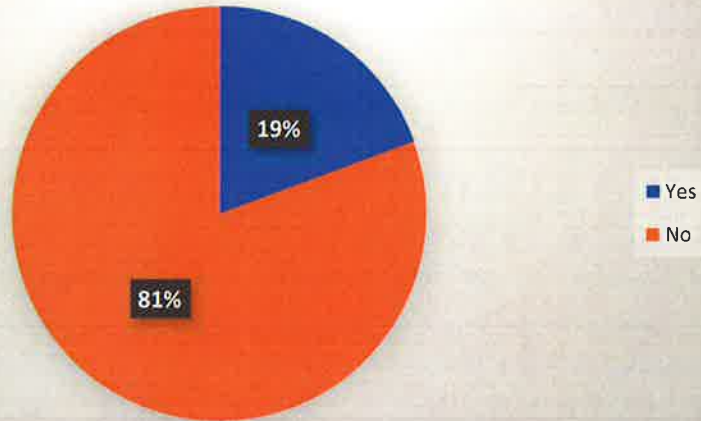

JEFFERSON COUNTY ALCOHOL TREATMENT COURT – OWI 3 & 4 PHASE REQUIREMENTS

Phase Descriptions and Goals

Phase 1 – Stabilization: (4 Weeks)

This Phase is designed to evaluate, closely monitor and ‘stabilize’ participants. Participants will need a period of time to become accustomed to the requirements of a treatment Court but must be closely monitored. Participants must enroll in treatment during this phase and must have their initial appointment with their treatment provider. Those already in treatment at the time they begin the program could advance early if all other requirements are met. Community Support is introduced to participants during this phase. Participants must have 20 days sobriety to advance to Phase 2.

Phase 2 - Engage in Treatment-Continue Recovery: (8 Weeks)

This Phase is designed to closely monitor participants’ progress and sobriety while they are beginning treatment. Participants in Phase 2 are required to make Community Support a larger and regular part of their life, and must obtain a sponsor. They are also required to begin looking for work and to perform Community Service if not employed. Community Service is intended for participants to give back to the community, develop positive work habits and to engage participants in non-using activities with non-using people. Participants must have 40 days sobriety to advance to Phase 3.

Phase 3 - Continuation of Treatment-Establish Community Support: (12 Weeks)

This Phase is designed to continue close (but decreasing) monitoring of participants while they work toward completing treatment. Participants must continue looking for work and complete community service if not employed. They are also required to increase involvement in Community Support once treatment is completed as well as maintain regular contact with their sponsor. Emphasis is placed on increasing sources of community support. Participants must have 60 days sobriety to advance to Phase 4.

Phase 4 - Completion of Treatment-Maintenance of Recovery-Solidify Support: (14 Weeks)

This Phase is designed to monitor participants at a decreasing level following completion of treatment, establishment of longer-term sobriety and overall program compliance. Participants are expected to utilize their sources of community support to maintain sobriety more than program monitoring. Planning for long term sobriety is finalized and presented to the Treatment Court. Participants must have 60 days sobriety to advance to Phase 5.

Phase 5 - Maintenance of Recovery and Support-Program Exit: (14 Weeks)

The final Phase is designed to offer minimal monitoring and supervision while ensuring participants are utilizing their sources of community support. Long term sobriety planning is reviewed and revised where appropriate. Participants must participate in a Pre-Graduation Exit Interview (including a program evaluation) prior to graduating. Participants must have 90 days sobriety to graduate.
