All parks, park roads and parking areas shall be closed to the public and vehicular traffic, except police and emergency vehicles, from one [1] half hour after sunset to one-half hour before sunrise and no person shall remain in parks during said hours, unless authorized by the issuance of a permit therefore by the Parks Director. Recreational trails may be used at any time except as limited by order of the Parks Director. No person may hike or walk dogs on designated cross-country ski trails when the trails are snow covered in any park. Any person launching a boat at Rock River County Park or Cappies Landing during normal operating hours may utilize the park boat launches at any time outside of normal operating hours for egress purposes. During the calendar winter months of November through April, Korth County Park and Dorothy Carnes County Park East will be open from 6:00 a.m. to 9:00 p.m. daily to accommodate use and access to the groomed cross-country ski trails. The Parks Director may grant permits to groups for park usage outside of normal park hours for events consistent with the mission of the Parks Department, and shall report issuance of any such permit promptly to the Parks Committee. Phase II of Interurban Trail links Watertown to Ixonia

JEFFERSON—Not too long after opening Phase I, the Jefferson County Parks Department and its partners on the project have opened Phase II of the muchanticipated Interurban Trail to bikers, walkers and runners. The response to this trail being open has exceeded expectations," Jefferson County Administrator Ben Wehmeier said of the turnout of people to the path and general enthusiasm in the community. "This has provided a great opportunity to connect two of our communities and the greater region as a whole, with a great and safe recreational opportunity. As we prepare for the next phase, we know this opportunity will continue to only be enhanced."

Watertown Mayor Emily McFarland acknowledged that the community and county are outdoor recreation destinations and the Interurban Trail is an important piece of that.

"We were proud to open the trailhead in Watertown this past year, and seeing and biking Phase II of the project has been an incredible addition to our recreational offerings," the mayor said. "Sometimes people undervalue what quality recreation opportunities provide."

McFarland said they boost the local economy, bringing in visitors and getting residents out into the community.

"They are supports for health and healthy communities, both physically and mentally and they are economic development components," she said. "They aid in building communities people want to live in, and when people live in the city, they work and spend their money in the city."

According to Mary Truman, advanced program assistant with the county's parks department, the final signs are in place along the trail, finishing touches were completed, and trail closure signs were taken down last week.

"Phase II of the Interurban Trail offers trail users a safe, off-road opportunity to make the connection between Watertown and Ixonia," Truman said. "They can do this while exploring the countryside and enjoying all that lies in between." With both Phase I and Phase II completed, the Interurban Trail is now seven miles long and ready for bike and pedestrian traffic in both directions.

As of today, the trail extends from a trailhead on Watertown's east side, near Concord Avenue, to Ixonia.

According to the county, the Interurban Trail project has been broken down into three phases for planning and budgeting purposes.

Phase I runs, specifically, from near Humboldt Street in Watertown 2.3 miles east to River Road.

"The Watertown Trailhead provides excellent parking, seasonal restrooms and a bike repair station to tune up your bike," Truman said. "Phase I of the trail was completed earlier in the year and includes a 10-foot-wide paved trail and is highlighted by a three-span recreation bridge over the Rock River."

Phase II of the project has been under construction for the last four months. This phase added an additional 4.7 miles of paved trail through rolling, rural terrain.

The Interurban Trail is now a full seven-mile ride from the trailhead to County Highway F, just south of Ixonia. This second phase of the project was funded primarily through grants from the Wisconsin Department of Transportation and the Wisconsin Department of Natural Resources Stewardship Program.

Phase III of the project will extend from County Highway F east, and make a direct connection with the City of Oconomowoc and the Lake Country Trail of Waukesha County.

When things are truly complete, planners have said they hope that bikers will be able to ride safely and scenically from Watertown to the Milwaukee lakefront, wher could connect with the city's Oak Leaf Trail. "When completed, the Interurban Trail will be a full 11 miles long," Truman said. "Jefferson County is again working with its partners on the fundraising, design and engineering of Phase III of the project. We are currently fundraising for the project."

Anyone interested in donating can contact the county at 920-674-7540 for more information.

Truman also said trail use has already been great and she reminded new users to access the trail via the designated Watertown trailhead and review the posted rules and trail etiquette signs.

"We also ask all trail users to please respect our trail neighbors and abstain from parking along the road rights-of-way near the trail," she said, reminding the public to stay tuned for more updates on the progress of the final phase of the Interurban Trail project.

McFarland said she is excited for the next phase to be complete.

"It will open up the community to even more opportunity," she said.

SECTION 8.13. PARK AND TRAIL HOURS.

- (6) The Parks Director may grant permits to groups for park usage outside of normal park hours for events consistent with the mission of the Parks Department, and shall report issuance of any such permit promptly to the Parks Committee.

November 23rd, 2022 E-BIKE POLICY REVIEW JEFFERSON COUNTY PARKS COMMITTEE

NARRATIVE

Jefferson County Parks has seen an increase in requests and inquiries for use of e-bicycles, e-scooters, and e-skateboards on its paved bike trails. Jefferson County does not currently have an ordinance or department policy that governs the use of these vehicles on bike trails or other trails. All e-bicycles and other motorized vehicles are prohibited in parks except on trails designated and marked for their defined use unless otherwise noted at the park per the current parks ordinance.

Electric bikes, scooters and other electric vehicles are becoming increasingly popular and more frequent on Jefferson Countytrails. These vehicles have increasing range and speeds from 5 mph to 30+ mph. These speeds have a potential to create unsafe conditions for multiple user groups traveling on a single path at such varying speeds. Many municipalities that govern "Bicycle Ways" are creating policy to guide the acceptable use of multi-use trails for such purposes and limiting speeds.

Jefferson County's bike trails are built on property owned by multiple owners including Jefferson County, We Energies, and WisDOT lands. Jurisdiction and enforcement of any ordinances and limitations is the responsibility of Jefferson County, as is the liability of inaction per the current License and Operations Agreements. Both We Energies and WisDOT have been consulted and no direct recommendations have been provided regarding the use of e-vehicles on Jefferson County trails.

WDNR has also been consulted and provided feedback on reviewing WDNR policy governing e-bike use on State Trails. One reference was provided for trails funded through RTP not allowing any motorized vehicles, but an exception was drafted in the Federal Code providing local jurisdictions with the authority to grant exceptions for the use of electric bikes. Ultimate control is largely delegated to the local management authority.

- Jefferson Interurban Trail Shared Management
 - Waukesha County recently created an ordinance allowing Class 1e-Bikes, but no other electric vehicles on their trails in response to complaints of excessive speed. See Waukesha County Ordinance for more information.
- Glacial River Bike Trail Shared Management
 - Dodge County does not currently restrict any electric vehicles as defined below.
 - Rock County does not currently restrict any electric vehicles as defined below.
 - City of Fort Atkinson allows, by ordinance, allows????? e-bikes, e-scooters on its section of the bike path. See copy of City of Fort Atkinson ordinance on bike paths and electric scooters.
 - City of Jefferson does not currently restrict any electric vehicles on streets or trails.
- Other Regional Municipalities with Bike Path Management Responsibilities.
 - Dane County does not currently restrict any electric vehicles as defined below.
 - City of Madison does not currently restrict any electric bikes or scooters on its trails. The City is aware of the complaints due to speed, but allows all three types of e-bikes

and scooters on the trails. The City is actively working on a *share the trail campaign* to try and encourage more "common sense" trail usage.

- Wisconsin State Parks take a trail by trail approach. Some trails do not allow e-bikes and some do.
- Wisconsin DNR: Electric bicycles are allowed on some of the straight (linear) bicycle touring trails, but must observe a 15-mile-per-hour speed limit. (Note that any electric bicycle *capable* of more than 30 miles per hour is, under state law, a motorcycle and not a bicycle, and may not be ridden on any state trails that do not specifically allow motorcycles). Electric bicycles are not allowed on any other bicycle trails other than those indicated in the table below. Electric bicycles used without the motor engaged are allowed on all bicycle trails.

POLICY RECOMMENDATION

At this time, the Jefferson County Parks Department recommends updates to the Parks ordinance section 8.09 Non-Motorized Vehicles. This would include changing the name of this section to Trails, Paths, and Bike Paths. This would include a section for definitions for the below types of uses. This is a draft only, and will require review by Corporation Counsel.

Section 8.09 Park Trails and Bike Paths

- (1) Park Trails
 - a. No person shall operate or drive any motorized or non-motorized vehicle on a Bike Path or within a park except on trails designated and marked for their defined use.
 - b. An individual who is considered disabled can request through the special permit process, access to trails and paths deemed suitable within the park system, with a low-powered, mechanically propelled vehicle designed specifically for use by a physically disabled person.
 - c. No person may hike or walk dogs on designated cross-country ski trails when the trails are snow covered and groomed in any park.
 - d. Dog sledding is prohibited in all county parks, trails, and paths unless otherwise authorized by issuance of a special use permit.
- (2) Bike Paths
 - a. All Jefferson County Bike Paths are considered multi-use paths and open to pedestrians, bicycles, e-bicycles, inline skates, play vehicles, and electric scooters as defined below unless otherwise posted.
 - b. Electric vehicle users shall comply with Wisconsin Statutes, sections 346.77 through 346.82 at all times while on Jefferson County Bike Paths.
 - c. It shall be unlawful for any person operating a bicycle, e-bicycle, e-scooter, or other vehicle on a bike path to pass another person or vehicle traveling in the same direction on the path without providing a warning to the person being passed making it evident that the person being passed is aware of the passing vehicle's approach.

- d. Pedestrians shall at all times have the right-of-way upon paved multi-use recreational paths; and if necessary, the person driving such bicycle, e-bicycled or e-scooter shall dismount and exit the traveled portion of the Bike path to the extent necessary to prevent a collision.
- e. Bicycle riders shall proceed in the extreme right-hand lane of the drivers at all times, in a single file only.
- f. Any such person operating a bicycle, e-bicycle, e-scooter, or other vehicle upon Bike Path must have the bicycle, e-bicycle, e-scooter, or other vehicle under control at all times.
- g. All bicycles, e-bicycles, e-scooters, and other vehicles shall be restricted to 15 mph at all times when on Jefferson County Bike Paths that allow their use.
- (3) Definitions:
 - <u>Pedestrian</u>: means any person afoot or any person operating a wheelchair, either manually or mechanically propelled, or other low-powered, mechanically propelled vehicle designed specifically for use by a physically disabled person, but does not include any person using an electric bicycle, electric scooter, or an electric personal assistive mobility device.
 - <u>*Plav vehicle:*</u> Means a coaster, skate board, roller skates, sled, toboggan, unicycle, or tow vehicle upon which a person may ride and does not include in-line skates or electric scooters.
 - <u>In-line skates:</u> means skates with wheels arranged singly in a tandem line rather than in pairs.
 - <u>Bicycle</u>: vehicle propelled by feet or hands acting upon pedals or cranks and having wheels any 2 of which are not less than 14 inches in diameter.
 - <u>Electric bicycle (e-bike)</u>: means a bicycle that is equipped with fully operative pedals for propulsion by human power and an electric motor of 750 watts or less and does not exceed 20 mph. This excludes Class III electric bikes.
 - <u>Electric scooter</u>: means a device weighing less than 100 pounds that has handlebars and an electric motor, is powered solely by the electric motor and human power, and has a maximum speed of not more than 20 miles per hour on a paved level surface when powered solely by the electric motor. "Electric scooter" does not include an electric personal assistive mobility device, motorcycle, motor bicycle, electric bicycle, or moped.
 - <u>Bike Path:</u> All paved or graveled off-road trails managed by the Jefferson County Parks Department including the Glacial River Bike Trail, Jefferson Interurban Trail, and the Korth Park Connector Trail.
 - <u>Mountain Bike Trail:</u> An offroad trail designated for use by bicycles.

Stat 340.01 Vehicles - General Provisions, Words of Phrases Defined

(15ph) "Electric bicycle" means a bicycle that is equipped with fully operative pedals for propulsion by human power and an electric motor of 750 watts or less and that meets the requirements of any of the following classifications:

(a) Class 1 electric bicycle is an electric bicycle equipped with a motor that provides assistance only when the rider is pedaling and that ceases to provide assistance when the bicycle reaches the speed of 20 miles per hour.

(b) Class 2 electric bicycle is an electric bicycle that may be powered solely by the motor and is not capable of providing assistance when the bicycle reaches the speed of 20 miles per hour.

(c) Class 3 electric bicycle is an electric bicycle equipped with a motor that provides assistance only when the rider is pedaling and that ceases to provide assistance when the bicycle reaches the speed of 28 miles per hour.

- (15pm) "Electric personal assistive mobility device" means a self-balancing, 2-nontandem-wheeled device that is designed to transport only one person and that has an electric propulsion system that limits the maximum speed of the device to 15 miles per hour or less.
- (15ps) "Electric scooter" means a device weighing less than 100 pounds that has handlebars and an electric motor, is powered solely by the electric motor and human power, and has a maximum speed of not more than 20 miles per hour on a paved level surface when powered solely by the electric motor. "Electric scooter" does not include an electric personal assistive mobility device, motorcycle, motor bicycle, electric bicycle, or moped.

Wis Stat 346.803 Riding bicycle, electric scooter, or electric personal assistive mobility device on bicycle way.

(1) Every person operating a bicycle, electric scooter, or electric personal assistive mobility device upon a bicycle way shall:

(a) Exercise due care and give an audible signal when passing a bicycle, electric scooter, or electric personal assistive mobility device rider or a pedestrian proceeding in the same direction.(b) Obey each traffic signal or sign facing a roadway which runs parallel and adjacent to a bicycle way.

(2) Every person operating a bicycle, electric scooter, or electric personal assistive mobility device upon a bicycle way open to 2-way traffic shall ride on the right side of the bicycle way.

(3) Every operator of a bicycle, electric scooter, or electric personal assistive mobility device entering a bicycle way shall yield the right-of-way to all bicycles and pedestrians in the bicycle way.

(4) Except as provided in ss. <u>349.236 (1) (bm)</u> and <u>349.237</u>, a person may operate an electric personal assistive mobility device, or an electric scooter at a speed not to exceed 15 miles per hour, upon any bicycle path.

Wis Stat 346.806 Special rules applicable to electric bicycles.

- 1. Except as otherwise expressly provided, an electric bicycle and an operator of an electric bicycle shall be afforded all the same rights and privileges, and be subject to the same duties, provided in chs. <u>340</u> to <u>351</u> as a bicycle or an operator of a bicycle. An electric bicycle shall be considered a vehicle to the same extent as a bicycle.
- 2. A person operating an electric bicycle is not subject to the provisions under ch. <u>341</u>, <u>342</u>, <u>343</u>, or <u>344</u> relating to financial responsibility, operator's licenses, registration, or certificates of title.
- 3.
- a. A person may ride, with the power unit in operation, an electric bicycle upon a bikeway, as defined under s. <u>84.60 (1) (a)</u>, under the jurisdiction of the department of natural resources, subject to any restrictions specified in a rule promulgated by the department of natural resources under s. <u>349.18 (4) (b)</u>, or under the jurisdiction of a municipality or county, subject to any restrictions specified in an ordinance enacted under s. <u>349.18 (4) (a)</u>.
- b. A person may ride, with the power unit in operation, an electric bicycle upon a bikeway, as defined under s. $\underline{84.60(1)(a)}$, under the jurisdiction of the department, subject to any restrictions specified in a rule promulgated by the department.
- 4. No person under the age of 16 years may operate a class 3 electric bicycle. A person under the age of 16 years may ride as a passenger on a class 3 electric bicycle that is designed to accommodate passengers.

Federal Definition of E-Bike

US Code Title 23 – Highways, Chapter 2, Other Highways, Section 217 (h)

Electric bicycle.-In general.-The term "electric bicycle" means a bicycle-equipped with fully operable pedals, a saddle or seat for the rider, and an electric motor of less than 750 watts; that can safely share a bicycle transportation facility with other users of such facility; and that is a class 1 electric bicycle, class 2 electric bicycle, or class 3 electric bicycle.

Classes of electric bicycles-

1. Class 1 electric bicycle.-For purposes of subparagraph (A)(iii), the term "class 1 electric bicycle" means an electric bicycle, other than a class 3 electric bicycle, equipped with a motor that provides assistance only when the rider is pedaling; and ceases to provide assistance when the speed of the bicycle reaches or exceeds 20 miles per hour.

2. Class 2 electric bicycle.-For purposes of subparagraph (A)(iii), the term "class 2 electric bicycle" means an electric bicycle equipped with a motor that may be used exclusively to propel the bicycle; and

is not capable of providing assistance when the speed of the bicycle reaches or exceeds 20 miles per hour.

3. Class 3 electric bicycle.-For purposes of subparagraph (A)(iii), the term "class 3 electric bicycle" means an electric bicycle equipped with a motor that provides assistance only when the rider is pedaling; and ceases to provide assistance when the speed of the bicycle reaches or exceeds 28 miles per hour.

WHEREAS, a bikeway is defined under Wis. Stat. § 84.60(1)(a) as a public path, trail, lane or other way, including structures, traffic control devices and related support facilities and parking areas, designated for use by bicycles, electric scooters, electric personal assistive mobility devices, and other vehicles propelled by human power; and

WHEREAS, Wis. Stat. § 349.18(4)(a) states that the governing body of a municipality or county may, by ordinance, prohibit the operation, with the power unit in operation, of electric bicycles on bikeways, as defined under Wis. Stat. § 84.60(1)(a), under its jurisdiction.
