8. Discuss vision, goals, priorities and planning

Wehmeier provided a draft of the vision and goals for review.

Vision and Goals

- Vision – Jefferson County will have best of class solutions that provides access and affordable broadband for residents, workforce, businesses (to include agribusiness), educational entities, health care, non-profits and local government that facilitate equal opportunities to compete as a region of choice.
- Goals – Jefferson County will work in partnership with stakeholders to accomplish the following:
 - Provide access to information for service availability and affordability
 - Work with partners to continue to identify gaps in service and cooperatively work on funding opportunities to accelerate service expansion (continuous gathering)
 - Continue efforts to develop ease of doing business in build outs – changing technology
 - Work with partners from providers and educational entities for technology education (facilitation)
 - Continuous feedback – changing technology and infrastructure to support – continuous improvement

Proposed Bead Budget - \$20,171.15

- Promotion/Marketing of data collection and surveys - \$1,171
 - Social media pushes
 - Potential postcards
- Data collection of providers in county; develop resource tool kit of information to include subsidized programs for broadband access – County Website \$4,500
 - Potential consulting time for data collection
 - Upgrade to website if needed
- Gap analysis – greater in-depth review of current and planned projects with ISP to identify primary gaps and ISP to partner with to fill gap; update GIS layers as able to - \$14,500
 - Primarily consulting time to review data
 - Potential assistance for GIS layers

June 14th is the date we have to have our plan in place.

Proposed Bead Budget - \$20,171.15. Promotion and marketing, data collection, Gap analysis.
