



DECEMBER 2023 REINCARCERATION GRAPHS


INCARCERATED AT JESO WITHIN LAST 3 YRS














WEAPON USED (NEW CHARGES ONLY)?

HOUSING STATUS (SENTENCED INMATES ONLY)




EMPLOYMENT STATUS (SENTENCED INMATES ONLY)







EDUCATION LEVEL (SENTENCED INMATES ONLY)










