I am wondering if you would consider reinstating the option for the 'participant pledge drive'. After reading the DRAFT I noticed that this was not an option this year so I reached out to Mikayla. She mentioned that the advisory board did not want to do the participant pledge this year and offered for me to come today for public comment.

I am asking for reconsideration and this is why.......

This would be my oldest child's fourth summer showing at Jefferson County and it is a great little fair that my family enjoys coming to each year. Our first summer here was a learning experience for sure, so we sided with selling two goats since goats were part of the small animal auction back then. Then the goats shifted to large animal the following year when Brian was here and my son couldn't decide what to sell that summer, so he opted not to sell an animal at Jefferson. We were not exactly sure what the whole pledge drive thing was either since it was new so we just chose to do nothing. So last year/summer, he choose to sell a sheep, which he was super excited about, however, we did ask for showing rights so he could show at State Fair. We even spoke to the buyer about it and everything was a go until it wasn't well after the fair was over. Long story short it was a nightmare and one frankily my kids don't want to go thru again either (or at least our son because our daughters buyer let her keep her lamb so that was a win). Anyways, of course, I know that my kids choose to ask for showing rights but why some may be asking.....well BECAUSE they LOVE to show their sheep and we travel A LOT during the spring and summer months and even into the fall, so yes it is our family's choice but one that we choose to do and we choose to do it as a family.

But after that dilemma last summer, the kids said they wanted to try the 'participant pledge drive' this summer and with much less headache. So the kids were looking forward to it. However, they were whole heartedly disappointed when they saw the DRAFT of the auction for this summer.

After reading the draft, I thought it must just be a misprint, because I remember sitting and watching the kids that took part in that pledge drive last summer and seeing all the smiles and their faces just light up with per joy with all the bidders that were supporting them; and there were only 5 kids. It was so awesome to see the bidders that were still in the arena and wanting to help those kids that were not offering an animal to sell. I just couldn't believe the support they got. It was quite exciting to see all the bids compared to the previous year that it was done when there were only 2 participants and fewer bids but last summer cards were flying all over the place. It was GREAT to see!!!! This 'participate pledge drive' is still new and growing. To go from 2 participants to 5 was nice to see, and I was anticipating seeing even more this summer as well.

So, my kids were definitely looking forward to having the chance to go that route this summer without the headache of asking for showing rights. So if you wouldn't mind, if you would kindly take the time to re-evaluate a GREAT thing that Jefferson County Fair has to offer to the youth, it would kindly and greatly be appreciated. It is something that we have never seen at any other county fair around! It is also a nice option for the bidders especially for ones that don't want to buy animals and they still feel they are able to support the local kids of Jefferson County without much being invested but still investing in the kids projects (3)
