Incident Log:

- March 15th storm blew off sections of roof from the goat barn at Fair Park
- March 15th power blip at the Courthouse
- April 21st power blip at Courthouse
- May 10th water main failure at Courthouse
- May 19th Identified fire alarm panel at Fair Park is not supported by manufacturer
- May 20th Chiller failure at Courthouse, blown fuse
- May 20th Discovered panic buttons do not work at HS
- June 6th Brush mower disrupts power at HS
- June 9th Discovered Sheriff / 911 radio towers were not being properly maintained
- June 23rd Power blip / lightning strike at Courthouse, chiller issues w/ pumps indicating inappropriate voltage / amps, emergency lighting, and panic button systems all impacted. Emergency Generator to be programmed to come on line 2-4 minutes after power outage in an effort to reduce impact of start stop and risk of double feed
- July 2nd chiller #01 won't operate, trips out because of low oil temp, force chiller #02 to continue operations, Vendor requested a new panel to get back to an operational state
- July 11 Power blip from city utility power, reset the entry doors, Jail central controller...
- July 14th Chiller #01 controller / wiring melt down
- July 16th Tornado alert, FA panel in service, break down to process identified, lack of emergency alert system for all employees
- July 21st Overhead door at the Sallyport portion of the jail backed into by Sheriff Deputy
- July 27th Courthouse Emergency Response Module(Panic Buttons) required manual reset, system is monitored by FA and dispatch is notified
- July 28th Water valve at WFD struck by lawn mowing equipment
- August 15th Chiller #01 failure appears to be a similar controller / wiring melt down
- August 16th mold discovered in the Lueder Haus, Brian is working to collect air samples, Jared dispatched for enhanced cleaning efforts
- August 17th Discovered AT&T contractor installed fiber optic cabling through the hiking and biking trails adjacent the Lueder Haus in an effort to create a temporary repair.

- December 16th Jail flood associated with failed valve repair on water closet near kitchen, fortunately damage limited to annunciator panel, carpet replacement, and ceiling panels
- December 19th (4) power blips with in a matter of five minutes, each lasting a fraction of a second and do not push us to emergency generator power but the Courts technology infrastructure was down for 30+ minutes. No other interruptions identified
