Discussion on identifying an agent to oversee contracts and maintenance efforts. No action taken at this time

Luckey presented information on the WIG-HEART grant and how Jefferson County can use the WIG-HEART grant to advance the EMS Working Group's goals of building a stronger pipeline of well-trained EMTs and paramedics. Supplemental information in packet provided. Group asked Luckey to draft a grant proposal. Another item considered was how to provide proper data to the community. A meeting of the EMS chiefs will be set up by Wegner and Peterson and Luckey will provide a presentation for that meeting when a date is decided. Luckey will also follow up with city, village, and town leadership to keep them aware of progress.
