Dear Property Owner,

Jefferson County and the Wisconsin Department of Transportation are proposing to construct a multiuse trail within the We Energies corridor in Jefferson County. The County has contracted with KL Engineering, Inc. to complete the design. You are invited to the Public Involvement Meeting for this project. Due to the added challenges of COVID-19, we will be hosting the Public Involvement Meeting (PIM) for the project virtually.

The trail will utilize the former Interurban Rail Line which now serves as a We Energies/ATC utility corridor. This segment (Phase 2) of the trail begins SE of Watertown near the intersection of River Rd and River Ridge Lane. The trail will continue 4.7 miles to the SE to CTH F, just south of the Town of Ixonia. It is the middle section of a transportation route between Watertown and Oconomowoc constructed along this corridor. The trail will have a 10-foot wide asphalt surface with 2-foot wide gravel shoulders. Construction is anticipated for the Spring of 2022.

The meeting will be live on Wednesday, October 21, 2020 from 3:00 pm to 4:30 pm in a virtual video conference format. The meeting will start with a short presentation that will provide an overview of the project. After the formal presentation, general questions can be submitted via chat and the County will address to the greatest extent possible at the meeting.
