

**Jefferson County Board
Committee Minutes**
May 23, 2012
Infrastructure Committee

1. Call to order

Meeting called to order by Supervisor Reese at 10:30 a.m.

2. Roll call of Committee Members

Rick Kuhlman, Russell Kutz, Don Reese, and Dick Schultz. Richard Jones, Excused.

3. Certification of compliance with the Open Meetings Law

The County Administrator reported that the revised meeting agenda dated May 18, 2012 was properly noticed in compliance with the law.

5. Public Comment

None

6. Election of Committee Officers

Supervisor Kuhlman nominated Don Reese for Chairman. Supervisor Schultz moved to close the nominations; Second by Supervisor Kutz to approve Don Reese as Chairman. Ayes-All (Motion Carried).

Supervisor Reese nominated Rick Kuhlman as Vice Chairman. Supervisor Schultz moved to close the nominations; Second by Supervisor Kutz to approve Rick Kuhlman as Vice Chair.

Supervisor Kuhlman nominated Dick Schultz for Secretary. Supervisor Kutz moved to close the nominations; Second by Supervisor Reese to approve Dick Schultz as Secretary.

7. Approval of the March 21, 2012 Infrastructure Committee meeting minutes

Motion made by Supervisor Kuhlman; Second by Supervisor Reese to approve the March 21, 2012 Infrastructure Committee meeting minutes as printed. Ayes-3 (Kuhlman, Reese and Molinaro) (Motion Carried).

8. Communications

9. Discussion and possible action on bids for Courthouse Parking Lot Project

Gary Petre reported that the bids were opened on May 16th with four County staff members present. Ron Bernhagen, from GMA Engineering discussed the project bids

Tri North Builders was the low bidder.

The Base Bid of \$221,000, and the Alternate Bid #1 of \$29,000 were recommended. Alternate bids #3, #4, and #5 will be determined by field conditions.

Ron Bernhagen stated that he would inform the bidders of the Committee's recommendation and the State's responsible low-bid requirement.

Motion made by Supervisor Kuhlman; Second by Supervisor Schultz to recommend the Base Bid, Alternate Bid #1, and other alternates as needed from Tri North Builders for the Courthouse Parking Lot Project. Ayes-All (Motion Carried)

10. Discussion and possible action on utilizing High Meadow Farm on a trial basis in 2012 for a Community Supported Agriculture (CSA) program at the County's Courthouse

Supervisor Christensen introduced Meg Kelly from High Meadows Farm. She explained how CSA programs work.

Phil Ristow discussed some insurance and ethic issues for the committee to consider. Molinaro would like to use a farm within Jefferson County. HR was asked to send out an email to see if there is any employee interest in participating in this type of program.

Motion made by Supervisor Schultz; Second by Supervisor Kuhlman to support the CSA program. Ayes-All (Motion Carried)

11. Update on the current status and condition of the Sheriff's Office Annex Building, the proposed study for recommendations on how to repair or replace existing building

Chief Deputy Parker provided information for the committee to review. Sheriff Milbrath discussed the condition of the Sheriff's Office Annex Building.

Motion made by Supervisor Schultz; Second by Supervisor Kuhlman to hire GMA Engineers to conduct a study and establish a cost estimate for the Sheriff's Office Annex building project. Ayes-All (Motion Carried)

12. Discussion and possible action on the Storage Building located on site at the Annex building

Sheriff Milbrath suggested that the Committee table this item until information is available concerning the condition of the Sheriff's Department Annex Building. No action taken.

13. Discussion and possible action on addition of a new courthouse security entrance

Gary Petre provided the committee with the October 9, 2008 Infrastructure Committee minutes and previous drawings of a new courthouse security entrance that were designed by Design Alliance.

Motion made by Supervisor Kuhlman; Second by Supervisor Schultz to request contingency funds, if needed, from the Finance Committee to proceed with updating the security entrance plans from Design Alliance and get a cost estimate for this project. Ayes-All (Motion Carried)

14. Update on county staff bringing Oleoresin Capsicum (OC/Pepper Spray) into the building for personal protection

Gary Petre was in contact with Child Support and Human Services regarding employee use of OC/Pepper Spray. Employees are no longer bringing this into the courthouse or using it while on County business.

15. Discussion and possible action on amendments to the County Weapons Policy

Phil Ristow provided a draft of the resolution for the committee to review. He went over the revisions.

Motion made by Supervisor Kuhlman; Second by Supervisor Kutz to approve the amendments to the Resolution regarding the County Weapons Policy and the County's Grounds Use Policy and forward it to the County Board for their consideration. Ayes-All (Motion Carried)

16. Discussion and possible action on amendments to the County's Grounds Use Policy

This item was acted on with Item 15. No further action taken.

17. Update on Highway Facility Project

Bill Kern updated the committee on the Highway Facility Project. No action taken.

18. Update on purchase of land for Highway Satellite Shop

Phil Ristow told the Committee that there is a signed offer to purchase on the property in Lake Mills, contingent on the Department of Transportation (DOT) putting up a salt shed and access road. No action taken.

19. Discussion and possible action on Resolution 2012-17 "Establishing a decision making procedure for selecting the site for new Highway Department Facility"

A copy of the resolution was provided for the committee to review. Supervisor Schultz explained his motivation for the resolution. The committee discussed the decision-making procedure. This item will be placed on the May 30th Infrastructure Committee agenda. No action taken.

20. Discussion and possible action on Resolution 2012-18 "Establishing policy for commemorative personal recognition signs or plaques on county property"

Supervisor Zentner explained his reasons for supporting this resolution and requested the support of the Committee. The Committee would like Phil Ristow to find out if other counties have similar policies regarding commemorative personal recognition signs or plaques on county property. This will be discussed at a future meeting. No action taken.

21. Discussion and possible action on wireless internet service at the Health Department and the Workforce Development meeting rooms

Gary Petre explained that they are proceeding with providing wireless access in the Health Department.

The Human Services Department did not want wireless access at this time.

The County is taking over the wireless infrastructure from the Workforce Development Center. We will be using that, plus some additional wireless access points, to provide wireless internet service throughout the building. We will be working on this project during the month of June, but have no estimated completion date at this time. No action taken.

22. Discussion and possible action on the Courthouse bathroom remodeling projects

Mark Miller informed the Committee that an issue has come up with the Americans Disability Act (ADA) laws which affect the current plans for the bathroom projects. Gary Petre has been in contact with Norm Barrientos for some direction on this project. No action taken.
