## 12. Discussion on completion of Segment I of the Interurban Trail

Tietz – first bridge over the Rock River has been installed. We Energies has stated that the bridge cannot open until the trail is repaired (highway E to bridge), and then bridge to River Road. City of Watertown will repair the damaged section, but cannot provide the recycled asphalt from the bridge to River Road.

Nehmer – will work with the Jefferson County Highway Department and County Administrator to determine what is possible. No action taken.

# 13. Discussion on Wisconsin Department of Transportation TAP Grant Request for Proposals Engineering Design Services Interurban Trail Segment II

Udovich – solicited 12 firms, received responses from 9. Selection group needs to meet, select a list of firms to interview.

Nehmer – applying for Stewardship grant for phase II for construction (20%) and engineering (100%) costs. Grant request may total more than \$400,000. Applications are due May 1, 2019.
