# **HIGHWAY COMMISSIONER'S REPORT:**

# • Construction Projects

CTH "N" (CTH "B" – CTH "A") – Reconstruction (Construction, Pave, Shoulder)

Schedule: May 1 – November 21

Progress: Crews are working on both ends of CTH N, there is not any substantial base under the pavement and the sub-base material is very poor. Most of the road has needed to be undercut by 3 to 5 feet. Crews are working on the road cuts first, along with drainage improvements, additional slope work will be needed as project progresses. 20% complete.

<u>CTH "G" (US 18 – STH 89) – Resurfacing (Pulverize, Pave, Shoulder)</u>

Schedule: May 27 – June 13

Progress: Project is complete

CTH "W" (STH 26 – Collins Road) – Resurface (Pulverize, Pave, Shoulder)

Schedule: June 2 – September 15

Progress: Removed asphalt, concrete, and poor soils on the section between Collins Rd and Annex Rd. New base course was placed and a schedule for paving the binder asphalt will be determined.

The updated schedule is to work on the remaining section of CTH W between Annex Road and STH 26 in August (August 4 – August 28).

15% complete.

CTH "A" (Crossman Road – Lake Mills) – Resurfacing/Reconstruction

Progress: Survey is complete, design work is in progress. An initial design overview meeting will be held with existing landowners in August.

#### • General Maintenance

Crews are completing various signing repair work and numerous sign/post replacements

First cut of mowing on all state and county highways is complete

Crews completed an interstate overlay/patch on I-94 in Johnson Creek

Crack seal work on county highways is complete

Crack seal work for the DOT will be scheduled in August (Special Contracts)

County seal coating for county highways is complete, seal coating for other counties, towns, and villages will be completed in August and September

# • Office/Shop

Office staff has completed the 2013 financial report summary Administrative staff has completed the 2015 budget

Design work is still in progress for CTH "J", CTH "A", and CTH "P"

Shop staff is identifying equipment to move to the new facility and also equipment needed to be replaced

# 9a. Discuss 2015 Highway Department budget

Commissioner Kern discussed the 2015 construction projects: CTH A (Lake Mills – Watertown) 10.25 miles; pulverize, pave, and shoulder: CTH A (Crossman Road – Lake Mills) 1.25 miles; R/W, construction, rehabilitation, pave, and shoulder: CTH J (STH 89 – Jefferson) 1.0 miles; pulverize, construction, pave, shoulder (facility entrance). The seal coat projects for 2015: CTH SC (US 16 – Dodge County) 2.7 miles; CTH A (US 18 – Crossman Road) 3.4 miles; CTH B (Dane County – Lake Mills) 5.2 miles. He also informed the Committee of a 15% salt price increase for winter maintenance, a decrease in CHIP funding from the State for 2015, and the replacement of the highway fleet in the future. # 9b. Highway Facility project construction update

County Administrator Wehmeier updated the Committee on the lime stabilization process that was done. He stated that the process created a good base and that the cost came in better than expected. The footings are 80% complete and the pre cast materials will be showing up this week for erection. He stated that there may be a good possibility that the outer shell of the building may be in place by the ground ceremony on August 11. There was discussion on Infrastructure agenda items regarding the cost of tubing for radiant heat and a voice alarm system. The Committee's questions were answered by Administrator Wehmeier and Commissioner Kern. No Motion

The Highway Commissioner discussed the financial account summary with the Committee. He handed out and discussed a mowing summary for 2012 and 2013. Questions from the Committee were answered. No Motion
