Gerry Arnolt from Cousins Subs talked to the committee about the Cousins lunch wagon that travels to different businesses.

Motion made by Supervisor Kuhlman; Second by Supervisor Jones to allow one vendor per day to provide food service to the Courthouse and Human Services. (Ayes-All)

9. Discussion and possible action on serving coffee at the courthouse - Tan'A'latte

Gary Haag from Tan'A'Latte proposed the idea of serving coffee, muffins and bagels in the courthouse.

Motion made by Supervisor Jones; Second by Supervisor Schroeder to allow Tan'A'Latte to serve coffee and pastries in the courthouse. The location will be determined after talking with the Sheriff's Department. (Ayes-All)
