- 3. <u>Certification of compliance with the Open Meetings Law</u>. Verification of notice of meeting by T. Palm.
- 4. <u>Review of Agenda</u>. Reserve right to re-order agenda items as needed.
- 5. <u>Citizen Comments.</u> None
- 6. Motion by C. Knox, second by J. Braughler, to approve the June 17, 2008, minutes as printed. Motion carried.
- 7. Motion by L. Zastrow, second by J. Braughler, <u>to recommend a resolution to approve the creation of two part-time</u>, <u>non-benefited</u>, <u>File Clerk positions</u>, <u>and hold one full-time File Clerk position vacant in Human Services</u>.</u> Motion carried.
- Motion by L. Zastrow, second by J. Nelson, to recommend a resolution to authorize the County Administrator to enter into amendments to the current AFSCME labor contracts to adjust the wage scale and rates for registered nurses, as well as authorize hiring rates up to Step 8 for experienced nurses. Motion carried.
- 9. Motion by J. Nelson, second by L. Zastrow, to convene into closed session pursuant to Section 19.85(1)(b), consideration of employee discipline and section 19.85 (1)(f), consideration of employee(s) specific medical history as it relates to a leave of absence request(s). All present responding "Aye" and convened into closed session at 11:01 a.m.

Motion by C. Knox, second by L. Zastrow, <u>to approve the Sheriff's recommendation of a</u> <u>10-day unpaid discipline</u>. Motion carried with a vote of 4 to 1 (J. Nelson).

- 14. Report from Human Resources including <u>three emergency help requests approved</u>, <u>15</u> <u>requests to fill vacancies, information on an upcoming Employee benefit Fair in October</u>, <u>and wages and benefits offered to the Fair Director candidate</u>.
